Before SPAETH, CAVANAUGH and VAN der VOORT, JJ. VAN der VOORT, Judge: Appellant was found guilty by a judge sitting without a jury on charges of simple assault and recklessly endangering another person. He was sentenced on both counts to one (1) to five (5) years on the simple assault count and three (3) to ten (10) years on the recklessly endangering another person charge, the sentences to run concurrently. Following trial, he was also found guilty on a third count of resisting arrest and sentenced to one (1) to two (2) years imprisonment to run consecutively to the sentences he received on the two other counts. It is appellant's contention that the trial judge erred by entering a judgment of sentence on the criminal recklessly endangering other person charge where the Commonwealth did not prove that appellant acted recklessly. We agree and reverse the judgment of sentence. The charges against appellant arose out of an incident which occurred on August 24, 1978. The Commonwealth called three police officers to testify. Officer Migliore testified that on the day in question he was on foot patrol. While he was "cross-street watching" appellant suddenly turned and started towards him, taking out what appeared to be a knife and swinging it in the air. Appellant looked like he was going to attack the officer. The officer drew his own gun and fired three shots at appellant. 82138339de
